## **Refund Criteria**

## **Donations:**

- + Refunds will be considered for donations made in error or where the donor has changed their mind within 15 days of the donation.
- + Refunds will not be considered for donations made in support of a specific program or project that has already been implemented.

# **Program Fees:**

- + Refunds will be considered for program fees paid in advance if the program is cancelled or postponed by the Foundation.
- + Refunds will not be considered for program fees paid for services already rendered.

## Other Payments:

+ Refunds will be considered on a case-by-case basis for other payments made to the Foundation.

#### **Refund Process**

Requests for refunds must be made in writing to mahananda.ngo@gmail.com

Refund requests will be reviewed and processed within 30 days.

Refunds will be made in the original form of payment.
